HIGH COURT CENTENARY CONFERENCE

A conference to mark the centenary of the High Court of Australia will be held on Friday and Saturday, October 10 and 11, with an official opening on Thursday, October 9.

The opening, in the Federation Ballroom at the Hyatt Hotel Canberra at 5pm, consists of a short historical film and brief speeches by Chief Justice of Australia Murray Gleeson, Attorney-General Philip Ruddock and Governor-General Major-General Michael Jeffery who will officially open the conference. This will be followed by a cocktail reception in the Great Hall of the High Court at 6.30pm. During the reception, the Federation Guard and the Royal Military College Duntroon Band will perform on the building forecourt.

Conference sessions, also held in the Federation Ballroom, will be divided into two themes: The Court in Australian Society and The Jurisprudence of the Court.

Under the first theme, the conference will explore the Court's first century, its relationship with government and the nation, and the break with the United Kingdom. The second theme will cover indigenous people, criminal law, federalism, torts, contract and commercial law, judicial review of administrative action, human rights, and equity and restitution.

Participants at the conference include Chief Justices from around the world, along with the Chief Justices of Australia's states and territories and the Federal Court and Family Court who will chair conference sessions. Guest speakers include Senior Law Lord and former Lord Chief Justice, Lord Bingham of Cornhill, Chief Justice of Canada Beverley McLachlin, Chief Justice of New Zealand Dame Sian Elias, former Chief Justices of Australia Sir Anthony Mason and Sir Gerard Brennan and former Justice Sir Daryl Dawson, Queensland Solicitor-General Pat Keane QC, Federal Court judge Mark Weinberg, Cape York Land Council adviser Noel Pearson and eminent academics from around Australia and from overseas.

Conference sessions and the opening ceremony are open to media. A program is attached.

The Centenary Dinner will be held at the National Museum of Australia on Saturday night. It is not open to media, but the pre-dinner entertainment at 7pm of an Aboriginal dance group on the museum forecourt, fireworks from a barge in Lake Burley Griffin in front of the museum, and a flame-out by an RAAF jet will provide spectacular picture opportunities.
